Addiction Pharmacology is a breakdown of the different types of abused substances, as well as the common medications used in the treatment of addiction. Explores chemical makeup, effects, symptoms, tolerance and withdrawal. The Treatment Modalities module explores the different treatment modalities and approaches commonly used in treatment of addiction around the world. Co-occurring Disorders explores the common disorders associated with substance abuse, whether occurring in conjunction with addiction or induced by it. The Process and Behavioral Addictions module then covers addictions other than chemical addictions. e.g. sex, gambling, eating disorders etc. Crisis Intervention looks at emergency psychological care, aimed at assisting individuals in a crisis situation to restore them to a functional state and reduce risks or potential for psychological trauma. And lastly the Detoxification in the Treatment Setting Explores the procedure of detoxification in the treatment setting and the different types of withdrawal symptoms and durations of withdrawal that can be experienced, depending on the types of substances used, quantities and duration of abuse.

Course Modules

- Please ensure you have specified whether applying for the distance learning or classroom option.
- Please ensure you have completed documentation and payment at least 2 weeks before the course date.
- Please ensure that you understand all information provided in this document, and that this document is signed before submitting it to ACCSA.
- Ensure that you have attached a scanned copy of your ID and proof of payment to confirm bookings.
- There is no previous education or experience requirements for applying for course modules in tiers one and two.

Online Distance Learning

- Logins to the ACCSA Online Distance Learning portal will only be approved, and passwords for course modules sent, once bookings have been completed and confirmed.
- There are no time constraints for online distance learning option. Courses can be booked and completed at any time convenient for the candidate.

Seated Course Lectures

- All documentation and payment must be completed and returned to us at info@accsa.co.za, and booking confirmed, or the candidate will be refused entry to the course.
- Candidates must be able to display identification upon arrival to the venue.
- Cancellations will only be accepted and refunds made, if ACCSA are notified at least 2 weeks in advance of the course date.

Examinations

- All examinations are multiple choice oral examinations held online using Skype. Candidates are to be in FULL view of the camera and may have no documents or devices in front of them. Candidates may not touch the keyboard or mouse unless instructed to do so.
- Examination bookings can be made by contacting us at info@accsa.co.za.
- Cancellations for examinations must be done at least two working days before the examination, to reschedule without an additional fee.
- Candidates who are more than 15 minutes late for the examination will have to make a new booking for their exam and will be charged an extra fee.
- For Tier 2 Packages, an overall combined examination is conducted and not individual module tests.

Certificates

- Please note that certificates will not be issued until a completed COURSE EVALUATION is received by us. Evaluations are mandatory for ACCSA audits.
- Single module certificates will be sent in digital format via e-mail. Only Tier 2 package certificates and Tier 3 Certifications will be sent via post.

Refund Policy

- Refunds for cancellations will be made as long as the cancellation is made sooner than two weeks before seated courses begin. If the cancellation is made after this time, a cancellation fee will be charged.
